

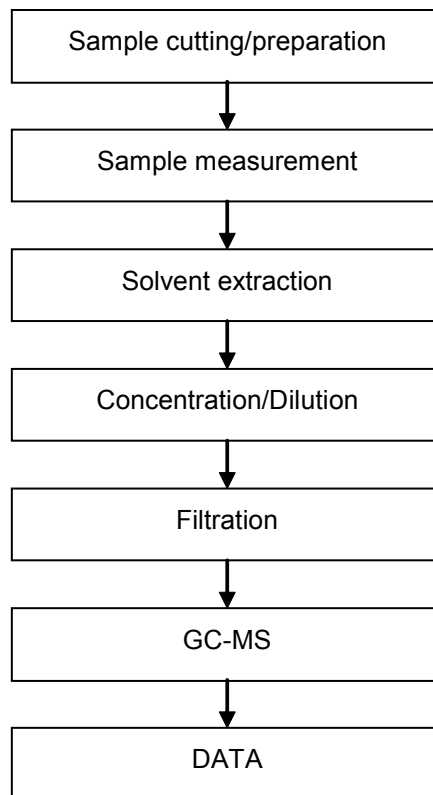

HBCDD Testing Flow Chart

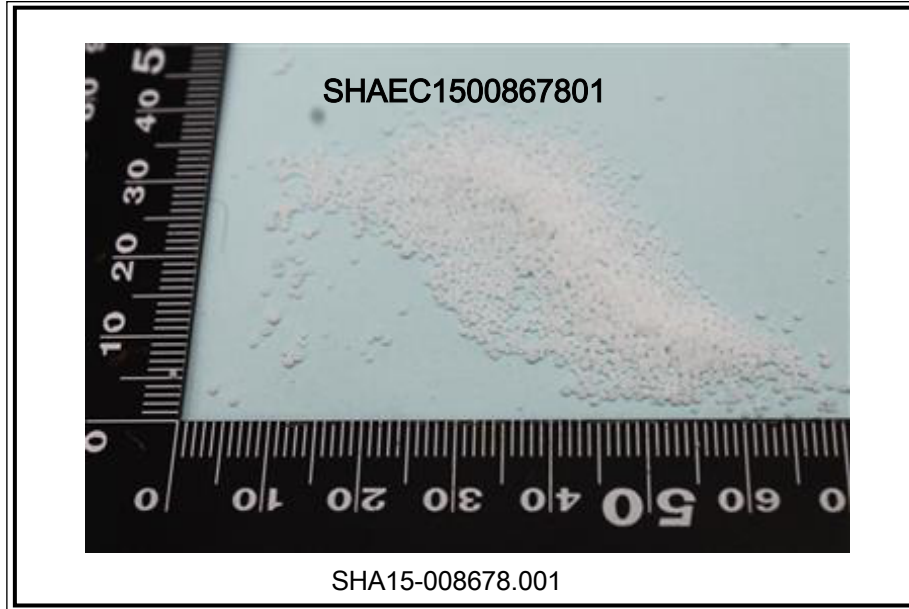
